Exploring the Ethics and Responsibilities of

4. Strategies for improving the professional ethics of medical students in internship

4.2 Strengthening the training of communication skills

Strengthening training in communication skills is crucial to enhancing the professional ethical qualities of medical students in the internship. Excellent communication skills not only help interns understand and answer patients' needs more accurately but also help build a doctor-patient relationship based on trust and respect. Training should include how to communicate information effectively, including listening to patients' requests and addressing their concerns and worries. For example, a medical student intern is responsible for the follow-up of a patient with chronic pain during her daily clinical practice. The patient felt anxious and helpless about the persistent pain and repeatedly complained about the lack of pain relief. Instead of rushing to give medical advice, the intern doctor chose to listen patiently, trying to understand the patient's feelings and giving full attention to the patient's emotions and needs. By listening carefully, the intern doctor not only learned about the patient's description of pain but also discovered the patient's psychological stress and concerns about the future. With this insightful understanding, the intern physician provides a fuller picture of the patient's condition when reporting back to the supervising physician, providing important information for developing an individualized treatment plan. This example demonstrates the patience, compassion, and listening skills required for interns to understand and handle patient complaints, which are key skills interns must learn and master in improving their professional ethics.

It should also include how to maintain good communication when dealing with sensitive and difficult situations, such as notification of illness, handling medical disputes, etc. At a deeper level, interns should be trained to demonstrate empathy and understanding in communication and how to communicate effectively when dealing with different cultures, beliefs, and values (Ai, et al., 2015). Only with these communication skills can internists truly respect and take responsibility for each patient in their daily medical practice, thus improving their professional ethics.

4.3 Ethical training through simulation and scenario-based teaching

Ethics training through simulation and scenario-based teaching is an effective means to enhance the professional ethics of internship medical students. This type of training allows students to experience and deal with complex situations involving ethical issues by simulating real medical situations in a safe environment (Gu, et al., 2012). For example, scenarios such as simulating interactions with patients' families, the informed consent process for patients, or dealing with medical disputes can help students preview the difficulties they may encounter in real healthcare settings and practice their decision-making and communication skills. For example, a simulation of an interaction with a patient's family could be set up in which the student intern explains a complex surgical procedure and its possible risks to the patient's family. In this simulation, the student needs to use his medical knowledge to clearly and accurately explain the details and necessity of the procedure, and he also needs to use good communication skills to enable the family to understand the complexity of the procedure and to accept and deal with the possible consequences of the procedure. During this process, the medical student intern must demonstrate compassion and understanding, respect the family's feelings and decisions, and be patient and attentive while conveying complex medical information. Such simulations help medical students-in-training experience and understand in advance the situations they may encounter in real medical settings, develop their decision-making and communication skills, and gain a deeper understanding and practice of medical ethical principles. During this process, experienced physicians and faculty can provide timely feedback to guide students on how to make decisions that are consistent with ethical principles in healthcare when they encounter ethical issues, improving their critical thinking and problem-solving skills. 4.4 Establishment and Adherence to clinical internship guidelines

Establishing and adhering to clinical internship guidelines is an important strategy to ensure that medical students in internships improve their professional ethics. First, these principles should clarify the roles and responsibilities of medical students in internships so that they are clear about their place in the healthcare team and the tasks they should undertake (Zhu, 2006). Second, the guiding principles of clinical practice should include respect for patient rights, such as maintaining patient privacy and respecting patient autonomy, to make the medical student intern understand that the well-being of the patient should always be at the center of the practice. addition, the guidelines should encourage self-reflection and evaluation by the internship students to increase their self-awareness of their behavior to continuously improve their professional ethics. At the same time, teachers and supervising physicians should also follow these principles as good role models to guide medical students in their internship to practice medical ethics properly and to build a noble physician character.

4.5 Guidance and Reflection in practice

In-practice mentoring and reflection important steps in enhancing the professional ethics of internship medical students. Mentoring in practice involves learning from experienced physicians in a medical setting to deepen theoretical knowledge, develop skills, and understand and adapt to the realities of medical practice. In addition, the mentoring process includes face-to-face feedback, which is an extremely valuable learning opportunity for practicing medical students to help them identify and correct their own mistakes, as well as help them understand their strengths and progress. Reflection is another key method for improving professional ethics. By thinking deeply about their actions and decisions, medical students in residency can gain a deeper understanding of their ethical understanding and practice to make more appropriate and ethical decisions in their future work (Gong, 2014). Mentoring and reflection go hand in hand so that medical student interns can continue to improve their professional ethics in practice, better serve their patients, and become excellent healthcare professionals.

Conclusion

In summary, this paper has explored the professional ethics and responsibilities of medical students-in-training in the doctor-patient relationship, elucidating their critical role in healthcare delivery while revealing the ethical challenges they face. We found that the professional ethics of internship medical students can be effectively enhanced by strengthening professional ethics education, providing guidance and reflection in practice, and conducting simulations and scenario-based teaching.
